Diane (Felbinger) Habiger

Diane (Felbinger '62) Habiger is definitely a product of Franciscan education having attended St. John the Baptist Grade School, St. Francis Academy and the College of St. Francis (now the University of St. Francis).

The Franciscan Charism has guided Diane her entire life.

Diane worked for Manpower Temporary Services in the early 80's where she discovered that employers were looking for temps who could do word processing and spreadsheeting. Diane taught herself both programs and convinced her employer that they needed to purchase computer equipment and train temporary workers who were sorely lacking in these skills. Diane started teaching both programs and trained temporaries who could fill the orders called in by employers. Diane also served on the search committee that recommended Dr. Arvid Johnson to serve as the ninth president of the University of St. Francis.

Diane has served on the board of directors for United Way of Will County and the Joliet Region Chamber of Commerce and Industry. She is a member of Joliet Rotary and has served on that board as secretary.

She received the first Marx Gibson Community Leadership Award, sponsored by both the Joliet Chamber and the University of St. Francis. Jen joined her husband, Vic, in the staffing industry and grew their first company, Adecco Personnel Services, into two successful territories including four On Site Accounts. The Kane and Birkey families include 51 Joliet Catholic High School, St. Francis Academy and Joliet Catholic Academy graduates.

James W. Missig '83 spent over 30 years in the

James W. Missig '83 spent over 30 years in the automotive collision repair business. At an early age he was attracted to custom cars and eventually became very fond of the collision repair industry. Jim at the age of 22 started his entrepreneurship in 1987 as owner of his first

store "Jim's Kolor Works". His first location was an old Quonset hut building of the "Navel Yards" in Rockdale, IL. Early in Jim's collision repair career, his business grew quick and in 1991 he was able to purchase his second store, located on Broadway street in Crest Hill, IL. At that point and time, Jim's business was renamed to be better identified to the collision industry, therefor

becoming "Kolor and Collision Works". Shortly thereafter in 1995, the Rockdale location was moved to Joyce Road in Joliet, which is currently being used for Jim's business CARCARE Towing.

Jim received most of his early knowledge of the Collision Industry by being involved in the National Automotive Service Association (ASA). He worked hard in the industry and became President of the local Joliet ASA Chapter from 1993 - 1997. In 1997, Jim became the State Vice President of the Automotive Service Association of Illinois and eventually took on the Presidents role from 1999 - 2000.

In 1997, Jim partnered with another local collision repair industry leader, together they developed "CARCARE Collision Centers" and "B&J Towing Service", currently known as CARCARE Towing. When Jim was President of ASA of IL, through his travels he recognized that there were two ways he could go and take his career in the collision business. One was to stay small and be comfortable, the other was to expand the business to a large corporation, Jim decided to expand. From 1997 - 2015 CARCARE Collision Centers had grown to 16 locations in Illinois with 200+ employees and was the predominate chain for collision repairs that performed approximately \$40 Million in repairs annually. CARCARE was sold in

2015 to a private equity owned national consolidator, Service King.

While in the collision business, Jim was also involved in many other business ventures, that company being called "AMW Ventures". Over the last 15 years AMW has developed land and numerous projects, incorporating over 285,000 square feet of commercial and multi-unit senior residential buildings, most of which is still owned. Today, Jim and his team have many exciting and largely needed projects in development that will bring needed services and benefits to our local communities.

In 2016 Jim and his wife Diana started "Missig Performance Group" (MPG), which is housed at the Joliet Autobahn Country Club. MPG collects and sells very high-performance cars, race cars and collectable cars. MPG is also the parent company that manages their son Jordan ("Jordan Missig Racing"), advancing his driving and racing career in motorsports.

Jim attended the Cathedral of St. Raymond, Joliet Catholic High School and Joliet Junior College. His community involvement includes the following both past and present: St. Joes Hospital Foundation Board, Joliet Junior College Mechanical Advisory Committee, Wilco Area Career Center Advisory Committee, Board Member of Minooka Baseball & Softball Association, and Joliet Catholic Academy Parent Board and the Investment committee. Jim has been involved in many other various advisory committees.
